ARTWORKS GRANTS 2025 — Terms & Conditions

- > ARTWORKS Civil Non-Profit Company (hereinafter referred to as "ARTWORKS") reviews the proposal in the application submitted by the applicant for the ARTWORKS GRANTS program (hereinafter the "Project"), for the purpose of awarding monetary prizes to artists.
- > The amount of the monetary award for each proposal is determined in the open call. It is not possible to increase the amount of the monetary award.
- > Applicants must maintain an active bank account with a Greek bank.
- > Applicants must accept our offer within two weeks of its receipt by accepting their award and signing a private agreement. If an applicant does not accept the award within this period, our offer will cease to be valid.
- > For applicants who are not selected, there is no procedure for revisiting or reconsidering the decision of the evaluation committee, which is final.
- > Applicants confirm that all the information included in their application is accurate. ARTWORKS may ask applicants to provide additional supporting documents.
- > Applicants accept that in the event of inaccurate or misleading statements or failure to submit all necessary information, their application will be rejected.
- > The full payment of the monetary award will be completed by the end of 2025. In the event that the recipient of the monetary award does not initiate the disbursement process by the end of 2025, its payment is not be carried over to 2026.
- > Award recipients must inform us if their plans or their ability to complete the Project change.
- > ARTWORKS reserves the right to request from the award recipients any relevant supporting document to verify that the monetary award was used for the purpose for which it was granted.
- > In case that the award recipient does not use the monetary award for the implementation of the Project, ARTWORKS reserves the right not to proceed with its payment and/or to request a refund of the amount already paid.
- > Award recipients must inform us if they receive any other funding for the Project from any other source, at any time until the completion of the Project.

The award recipients hereby grant us a royalty-free, a non-exclusive, worldwide, perpetual license to reproduce the Project and the Project proposal, to the extent that is reasonable for promotional and publicity purposes.
- > Upon completion of the Project, a copy of all printed and/or digital material (catalogues, relevant publications, etc.) must be sent to ARTWORKS. ARTWORKS reserves the right to share this material on its website and on social media.
- > Award recipients must inform us in writing as soon as possible if any funding agreement with another entity has been revoked or terminated due to misrepresentation and/or fraud on their part.
- > We source the financial support we provide to recipients from various funding streams.

 We do not expect this funding to be reduced or discontinued, however, if such situation arises, we may reduce or discontinue the provision of the monetary award before the full amount is paid.
